Pursuant to A.R.S. §8-1194 (A) and A.R.S. §38-431.02, notice is hereby given to the members of the First Things First - Arizona Early Childhood Development & Health Board, Navajo Nation Regional Partnership Council, and to the general public that the Regional Partnership Council will hold a **regular meeting open to the public on February 1, 2011, beginning at 1:00 p.m. The meeting will be held at the Karigan Professional Building, Classroom A/B, 100 Taylor Road, St. Michaels, Arizona 86511.** Some members of the Regional Council may elect to attend telephonically.
