CHILDS supports Hotline intake, initial assessment/ investigation, case management, adoption, eligibility determination, staff management, provider management and payment processing; and includes on-line help, policy, a court document and forms directory, an alert system for key case events, and other mechanisms to monitor and maintain data accuracy. The Team Decision Making database tracks all TDM meetings, their timing (before or after removal), participation by case role (mother, father, community partner, etc.), and the recommendations made regarding custody and/or placement. Each district is able to produce reports regarding the number of TDM meetings and recommendations made for children.
