**Expedited Home Visiting Strategy Discussion and Possible Award of Expedited Home Visiting Grants**

A statement was read by Aimee Kempton-Sarosi, Regional Coordinator, Pinal Regional Partnership Council to remind the Regional Council and the public that only those non-Regional Council members reasonably necessary to the Executive Session discussion may attend the Executive Session. A motion was made by Member Kai Gerkey to move into Executive Session pursuant to ARS 38-431.03 (A) (2), for the purpose of agenda item #2 – discussion of confidential information regarding expedited home visiting strategy and possible award of expedited home visiting grants, seconded by Member Chrissie Jenkins. Motion carried. It is approximately 10:22 AM. Council Member Melanie O'Neil was asked to step out of the meeting due to a conflict of interest.

Executive Session is recorded and the minutes are confidential.

A motion was made by Member Jenkins to close Executive Session, seconded by Member Gerkey. Motion carried. It is approximately 11:21 AM.

A motion was made by Member Jenkins to approve the review team recommendation to award agency profile 10-05 a \$500,000.00 grant for April 1, 2009 through June 30, 2010 to provide home visitation programs under the First Things First Emergency Early Childhood Response Program, seconded by Member Hernandez. Motion approved. The grant recommendation is as followed: FTF-HOME-10-05 in the amount of \$500,000.00. All Council Members were in favor where there was not a conflict of interest. Council Member O'Neil did not vote due to a conflict of interest.
