Meeting Minutes – November 10, 2014

Call to Order, Welcome, and Introductions

Chair Madrid called to order the Regular Meeting of the First Things First, <u>Gila River Indian Community Regional Partnership</u> <u>Council</u> held <u>Tuesday, November 10, 2014</u> at approximately <u>11:38 a.m.</u> The meeting was held at <u>Gila River Indian Community Early</u> <u>Education Childcare Center, 280 South Ocotillo Road, Sacaton, Arizona 85147</u>. Introductions were held and attendees were welcomed.

Meeting Minutes

Chair Madrid called for a motion to approve the October 21, 2014 Regular Meeting Minutes. Member Tatum moved to approve the meeting minutes as presented. Member Foote seconded. Motion carried unanimously.

SFY16-18 Strategic Planning

Review of SFY16-18 Regional Priorities

Director Brown provided a brief overview of FTF statewide strategic direction; vision, priority roles, school readiness indicators, and initiatives areas. She furthered reviewed the regional priorities for SFY16-18.

Review of SFY16-18 Funding Plan Scenarios

Director Brown explained the strategic planning process and the importance of programs' sustainability, expansion, infrastructure, partnerships and collaborations. She reviewed the council direction and process to date; and the resulting recommendations for strategies, funding, and service levels for SFY16-18.

Chair Madrid reminded Council members who may have a conflict of interest to disclose their interest and abstain from discussion and voting.

Council discussed the SFY16-18 strategic approach.

Chair Madrid asked Vice Chair Enos to conduct the meeting for the next items. Vice Chair Enos called for motions on each of the strategies.

Motions:

Member Nasewytewa moved to approve the <u>Home Visitation</u> Strategy in the amount of <u>\$150,000</u> for <u>SFY16</u>. Member Judge Hart seconded. Motion carried 7-0. *Member Foote declared conflict of interest, did not vote.*

Member Nasewytewa moved to approve the <u>Parent Education Community-Based Training</u> Strategy in the amount of <u>\$104,150</u> to for <u>SFY16</u>. Member Judge Hart seconded. Motion carried 7-0. *Member Foote declared conflict of interest did not vote*.

Member Nasewytewa moved to approve the <u>Quality First</u> Strategy in the amount of <u>\$55,912</u> for <u>SFY16</u>. Member Judge Hart seconded. Motion carried 7-0. *Chair Madrid declared a conflict of interest and did not vote.*

Member Nasewytewa moved to approve the Quality First Scholarships Strategy in the amount of \$260,091 for SFY16. Member Judge Hart seconded. Motion carried 7-0. Chair Madrid declared a conflict of interest and did not vote.

Member Nasewytewa moved to approve the Statewide Evaluation Strategy in the amount of \$28,762 for SFY16. Member Judge Hart seconded. Motion carried unanimously.

Vice Chair Enos excused himself at approximately 1:01 p.m. Chair Madrid continued the meeting.

Review of unfunded approaches to address priorities

Director Brown reviewed the "System Building Levers" which are roles and opportunities that the council may play in order to support partnerships and collaborations.

Director Brown shared the proposed unfunded approaches the Council has discussed in prior meetings, as supports for the Early Childhood System in the Gila River Indian Community. The Council reviewed and discussed the recommended unfunded approaches that align with the regional priorities and funded strategies. These include Health Connections, Children in Crisis, Seeking Public Private Partnerships to Expand Early Childhood Programs, Home Visitation Coalition, Partnering with Tribal Ed Department, and Literacy.

Member Tatum excused herself at approximately 1:45 p.m.

Chair Madrid called for a motion to approve the unfunded approaches.

Motion:

Member Foote moved to include the Unfunded Approaches, with today's additions, for SFY16-18 strategic plan. Member Nasewytewa seconded. Motion carried unanimously, 6-0.

Council Member Updates and Announcements

Gila River Indian Community Children in Crisis Coalition – Member Judge Hart announced that the Coalition did not meet in October and the next meeting is slated for November 17th.

Chair/Vice Chair Leadership Call with FTF Board Chair - Chair Madrid reported she and Vice Chair Enos did not attend the meeting.

Chair Madrid reported the Gila River Indian Community Early Education Childcare Center will be receiving a new Quality First Star Rating of 4 Stars. She is excited about the growth of the program through the program, and is excited to be able to share the accomplishment.

Director Brown stated the SFY16 Funding Plan and 2014 Needs and Assets Report will be presented to Tribal Council in December.

Adjournment and Next Meeting

The Council agreed to cancel the November 20th meeting. Meeting adjourned at 2:04 p.m.

Home visitation programing in the region is robust but coordination and collaboration would lead to additional families accessing home visitation. The Council chose to unfund family friend and neighbor support and focus on an unfunded approach to system building for infants and toddlers through a Home Visitation Coalition. Data from the Home Visitation Coalition will be utilized in the next funding plan cycle (SFY 2017) to better understand how to approach and support the infant toddler population and their families.
