


Community Households¹

- Children 0-5: 21%





Supplemental Nutrition Assistance Program Participation (July 2011)²

- Golden Valley: 255 (52% of children 0-5)
- Mohave County: 6,839 (52% of children 0-5)
- Arizona: 216,398 (40% of children 0-5)

- Golden Valley: Not available
- Mohave County: 7.4 per 1,000⁴
- Arizona: 6.7 per 1,000⁴
- Healthy People 2020 goal: 6.0 per 1,000⁵

Immunizations⁴

- Completion of recommended series, 12-24 months: 40 (77% of children 12-24 months)
- Completion of recommended series, 19-35 months: 41 (44% of children 19-35 months)

AIMS Scores (Black Mountain Elementary School, Kingman Unified District)³

Reading Scores (3rd grade)

- Falls far below standards: 2%
- Approaches standards: 19%
- Meets or exceeds standards: 79%

Math Scores (3rd grade)

- Falls far below standards: 6%
- Approaches standards: 30%
- Meets or exceeds standards: 63%
