

- Other, non-Hispanic: 2%


Community Households¹

- Average household size: 2.5


English ability for those who do not speak English at home (persons 5 and older)⁶

- Percent of households in which no person 14 and older speaks English (nor speaks "very well"): 1%


Average Unemployment²

- Kingman: 7.7 per 1,000⁴
- Mohave County: 7.4 per 1,000⁴
- Arizona: 6.7 per 1,000⁴
- Healthy People 2020 goal: 6.0 per 1,000⁵

Immunizations⁴

- Completion of recommended series, 12-24 months: 308 (71% of children 12-24 months)
- Completion of recommended series, 19-35 months: 288 (39% of children 19-35 months)

AIMS Scores (Kingman Unified School District)³

Reading Scores (3rd grade)

- Falls far below standards: 4%
- Approaches standards: 18%
- Meets or exceeds standards: 79%

Math Scores (3rd grade)

- Falls far below standards: 7%
- Approaches standards: 25%
- Meets or exceeds standards: 68%
